Badbury Park Primary School expects that through the Sports Premium finding spend, there will be:

- greater knowledge of planning, delivering and assessing sport within the staffing body
- there will be increased in knowledge and confidence of the sports leaders to assess sport;
- there is wider participation from all groups of children in lessons and after school club
- the school is more active within the school day meeting and in some cases exceeding 2 hours of good curricular PE a week
- increased resources to meet the growing needs of the school

Staff and pupil voice will show that as a result of the sports premium spending, there is:

- greater participation in sport and activities.
- The children are stronger and fitter in most cases and learning walks demonstrate how adaptations have enabled access to the lessons for all.
- Pupil voice of girls will show that enjoyment of PE is in line with the Youth
   Sport Trust Girls Active survey wherein, 86% of girls aged 7-9 said they enjoy
   PE.
